NOTIFICATION

Consequent upon ensuing State Legislative Assembly Election period in West Bengal, the question of maintaining effective, continuous and uninterrupted academic and administrative functions in all State-aided Colleges of West Bengal was under active consideration of the State Government from some time.

After consideration of all these aspects and also considering the fact that the State Government is under obligation in maintaining the Government-aided Colleges of West Bengal and to protect the interest of students, in such a manner so that the normal academic and administrative functions of all such college should not be hampered during ensuing State Legislative Assembly Election period in West Bengal in 2021, the State Government, in exercise of the powers conferred by section 18 of the West Bengal Universities and Colleges (Administration and Regulation) Act, 2017, is please to direct that

- a) the Governing Bodies/Administrators of all such Government-aided Colleges in West Bengal, whose tenure has already been expired as on the date of publication of this Notification, but reconstitution of the said Governing Body or Appointment of Administrator has not yet been made, shall continue to function with effect from their date of expiry with the same rights and privileges they were enjoying immediately preceding the date of the expiry of the Governing Body/Administrator till 30th June 2021 or the Governing Bodies are re-constituted/Administrators are appointed of any such colleges by the State Government, or until further order, whichever is earlier;
- b) the Governing Bodies/Administrators of all such Government-aided Colleges in West Bengal, whose tenure is going to be expired on or after the date of publication of this Notification within 31st May 2021, shall continue to function with the same rights and privileges they were enjoying immediately preceding the date of the expiry of their tenure till 30th June 2021 from the date of expiry of their tenure, unless the Governing Bodies are re-constituted/ Administrators are appointed of any such colleges by the State Government, or until further order, whichever is earlier.

earliest.
