Sub: Closure of Portal for Kanyashree Year 2020-21.

Sir,

Kanyashree Year 2020-21 commenced from April 2020, and is still open after a passage of nearly 2 years, allowing enrolment of eligible Kanyashree girls.

It may appear that the target for 2020-21 for enrolling K1 beneficiaries has been achieved. However, as is clear from the report at **Annexure-I**, 3368 girls have not yet been renewed for receiving their K1 scholarship. Similarly, 13118 girls have not yet been upgraded to K2.

The cases of all these girls must be disposed of immediately as per the scheme guidelines.

It is also to be observed from Column 4 of **Annexure-I** that 13744 girls who are eligible for renewal as K1 are marked as transferred out, but they have not been transferred in by any institutions as yet. The number of such girls for K2 is 16331 (Column 7 of **Annexure-I**).

You are requested to ensure that these girls are reached out to and are covered under Kanyashree after they are enrolled in an educational institution. The girls who are not eligible as per Kanyashree guidelines, must be marked as **“non-renewable / non-upgradable”** on the portal.

The time line for closure of the Kanyashree Year **2020-21** is as follows:

- a. Enrolment of fresh entry will be closed from 15th March, 2022, i.e. DPMUs have to complete all enrolments on or before 14th March, 2022.
- b. Sanction of entries will be closed from 1st April, 2022 i.e. DPMUs have to complete sanction of eligible beneficiaries within 31st March, 2022.
- c. Disbursement will be open.

The following Modules regarding enrolment will be closed on 15th March, 2022

1. Fresh K1 Entry	6. Transferred Reverted Cases for Class XII
2. Fresh K2 Entry	7. Partial Entry / Editing of fresh K1 / K2 forms
3. Renewal	8. Partial Entry / Editing of Renewal / Upgradation forms
4. Upgradation	9. Partial Entry / Editing of Re-Registration forms
5. Re-registration	10. Forwarding from HOI level
