### Sub: Closure of Portal for Kanyashree Year 2021-22

Sir,

Kanyashree Year 2021-22 commenced from April, 2021 and is still open. Applications of eligible Kanyashree girls are still being enrolled. Though it appears that the target of K1 has been achieved, we are yet to complete renewal of 7167 girls. These girls have already received K1 in 2020-21 KY and are eligible for K1 in 2021-22.

As regards up gradation, 28077 girls who have received K1 in the previous Kanyashree Year(2020-21 KY) and are eligible for K2 in 2021-22 KY are not yet enrolled as K2(enclosed as Annexure II).

Districts must take suitable measures by reaching out to the girls who are eligible for renewal /upgradation and marked as transferred out, but have not been absorbed (Transferred In) by any institution as yet. The girls who are not eligible as per the Kanyashree guidelines, must be marked as "non-renewable/non-upgradable" in Portal.

Physical progress of Kanyashree Year 2021-22 are enclosed for ready reference (Annexure I).

The time line for closure of the Kanyashree Year 2021-22 is as follows:

- a. Enrolment of fresh entry will be closed from 16<sup>th</sup> July 2022, i.e. DPMUs have to complete all enrolments on or before **15<sup>th</sup> July, 2022**.
- b. Sanction of entries will be closed from 16<sup>th</sup> August, 2022 i.e. DPMUs have to complete sanction of eligible beneficiaries on or before 15<sup>th</sup> August, 2022.
- c. Disbursement will remain open.

The following Modules regarding enrolment will be closed on 15th July, 2022

- 1. Fresh K1 Entry
- 2. Fresh K2 Entry
- 3. Renewal
- 4. Upgradation
- 5. Re-registration
- 6. Partial Entry / Editing of fresh K1 / K2 forms
- 7. Partial Entry / Editing of Renewal / Upgradation forms
- 8. Partial Entry / Editing of Re-Registration forms
- 9. Forwarding from HOI level
